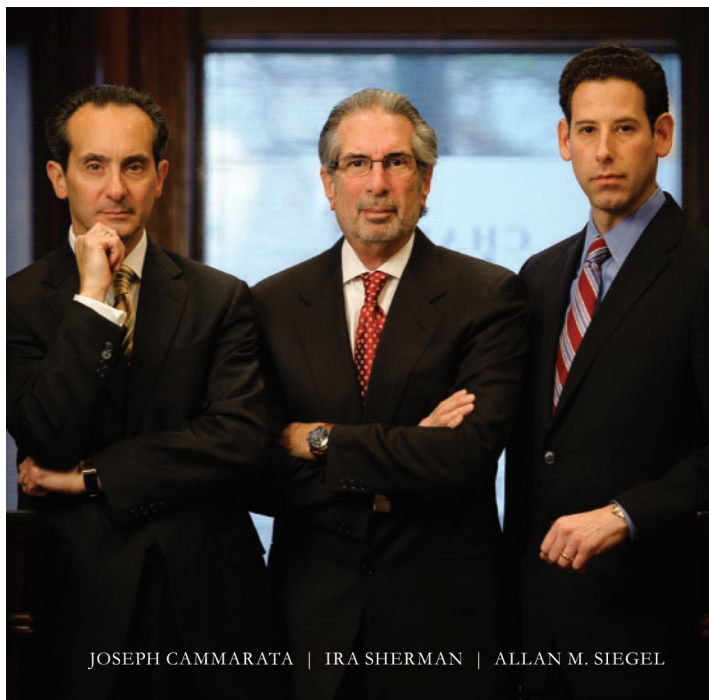
## *Washington DC Super Lawyers*<sup>®</sup> selected all three of the firm's partners to be included in its 2011 publication
