I also hope my prayer on January 21, 2009, that "this feeling [of pride] stays within each of us for many years to come, and that it fortifies us for the challenges to the justice system that we will be fighting in the future."

Perhaps, if each of us can recall the optimism of the day Barak Obama was inaugurated, and see beyond these darker days, hopelessness will not find its way into our hearts. I know we all feel a kinship towards each other. We are a community that is hurting now. Yet, we must do all we can to assure that we influence as many as we can to not react to the pain by inflicting pain on other innocents. I look forward to better days ahead.

### **COVID AFFECTS THE COURTS**

The global pandemic has touched every facet of our society, and the courts were no exception. Starting in mid-March, every court in the region was forced to shutter its doors to minimize the spread of the coronavirus. In the process, the courts cancelled nonemergency hearings and trials for a period of March through June. This resulted in the courts having to extend deadlines for the hundreds of thousands of lawsuits affected by the closure. The courts also extended statutes of limitations — the deadlines for people to file their lawsuits — during this period. These extensions were enacted so that no one would be prevented from seeking justice as a result of the court closures.



Now that the rate of new infections in our area is on the decline, the courts are beginning the arduous process of reopening. There are, however, many obstacles that must be addressed before normal court operations can be achieved. The most onerous obstacle is the backlog of hearings and trials that have to be rescheduled. This means that a trial originally set in 2020 may not be reset until 2021. The courts also have to address the continued danger of spreading the virus. Courts universally have been forums where the public gathers in large numbers. Jury trials in particular can bring anywhere from six to 12 people in close proximity with each other for a prolonged period of time, and the courts need to figure out how to conduct jury trials without spreading the virus. There are no easy answers to these difficulties, and each courthouse must individually determine what procedures to implement.

Ultimately, the courts will return to normal operations, as will the rest of our society. As your attorneys, we have implemented measures to track the various orders and operating procedures originating from each of the various courts in which we practice. We are always available to answer any questions you might have regarding how court operations may affect both your case and your health and safety.

# **CORONAVIRUS CAN'T STOP CSCS**

While the coronavirus has dramatically changed life for us all, it has not interfered with our ability to aggressively pursue justice on behalf of our clients. Even before the District of Columbia decided that it would close all nonessential businesses, we began making changes to ensure the safety of our employees and our clients.

We quickly transitioned our entire staff to remote working so that we could stay open and continue to advance our clients' cases. Our technology, such as our case management system, remote access systems, and advanced phone systems, allowed us to operate without skipping a beat. Many of you may have called the office during this time and heard Lynette's or Sharice's friendly voice, as you would normally expect. They transferred your call to your lawyer, or our team of professionals, and you probably never realized that we were spread out across the DMV while you were talking to us. We established a system so that videoconferences are readily available for anyone who wants to "meet" with us, and we transitioned many of our documents to DocuSign to make it easy for our clients to sign documents without having to come into the office.

We have also continued to fight for you every day since the pandemic started. We have conducted depositions, mediations, and arbitrations through videoconferences. We have also continued to resolve cases even though the courts have largely been closed, and have cancelled trials and hearings during the emergency.

In fact, we have been quite busy obtaining remarkable results for our clients. Some of the highlights are listed below:

- A \$311,000 arbitration award on behalf of a man involved in a T-bone collision who suffered a shoulder injury requiring surgery.
- An almost \$300,000 settlement on behalf of a woman who suffered a fractured pelvis as a result of a car crash.
- A \$250,000 settlement on behalf of a woman who suffered a brain injury in a car crash.
- A \$200,000 settlement on behalf of a man who was a passenger in a car crash, and who suffered a shoulder injury requiring surgery.
- A \$175,000 settlement on behalf of a woman who fractured her knee as a result of a car crash.
- Another \$175,000 settlement on behalf of a man who was rear-ended at a high rate of speed and suffered a
  back injury.

While this unprecedented time in our history has not been easy, we have adapted, and will continue to adapt, to ensure that we can serve your needs. While we hope that normalcy will return soon, we want you to know that our commitment to you, our clients, and the pursuit of justice will continue however long it takes, and regardless of the challenges that we may face.
