Partner Allan Siegel Wins \$700,000 Settlement

In most of our cases we are making claims that are covered by insurance. Unfortunately, there are many circumstances when the compensation our clients deserve far outweighs the amount of insurance available. However, we never leave any stone unturned in our quest to obtain complete justice for our clients.

To that end, Partner Allan Siegel recently obtained a \$700,000 settlement, in which the wrongdoer made a significant contribution of his own money. Our client suffered serious injuries. Mr. Siegel had an investigation of the at-fault party's assets conducted which revealed that the wrongdoer was going to be receiving a significant inheritance. Upon learning of the wrongdoer's expected inheritance, Mr. Siegel refused to accept the insurance company's policy limits offer of \$250,000, and our client was prepared to go to trial to obtain a fair verdict against the wrongdoer. However, facing the prospect of a jury trial, the wrongdoer's counsel requested that the parties attempt to settle the case by submitting to mediation. Ultimately, the wrongdoer agreed to contribute an additional \$450,000, above the insurance company's policy limits, bringing the total settlement to \$700,000, ensuring our client received fair compensation for his injuries.

Partner Joseph Cammarata is Elected to Chairman of a National Traumatic Brain Injury Litigation Group

The lawyers at Chaikin, Sherman, Cammarata & Siegel, P.C. have been in the trenches fighting for clients who have suffered brain injuries long before many understood the seriousness of this type of injury. Many years ago, it was expected that if a boxer "had their bell rung" they would get right back in the ring or if a football player hit their head they would "shake it off." Back then, it was not universally understood that you could suffer a concussion (which is a traumatic brain injury) even if you didn't actually hit your head, but just from the force of your head being tossed around in a car accident. While these concepts were novel back then, we represented clients who had serious and sometimes life-long effects from this kind of head trauma, and obtained compensation for them, against all odds. Now the science has caught up, and it is well known that concussions are serious brain injuries, and they can be identified as separate, significant, lifealtering events.

Based upon our experience in this area, we are often invited to teach other lawyers about brain injury. Partner **Joesph Cammarata** was a co-founder, with Partner **Ira Sherman**, of the Brain Injury Association of Washington, DC. In addition, Mr. Cammarata drafted legislation, which became the law in the District of Columbia, protecting youth athletes from concussion.

Mr. Cammarata's role in the brain injury community has led to his selection as Chairman of the American Association for Justice's Traumatic Brain Injury Litigation Group, which is comprised of other lawyers throughout the country dedicated to representing brain injury victims. Congratulations to Mr. Cammarata on this honor!

Maryland Voters Increases the Amount of Damages Required for a Jury Trial

Maryland voters in the past election passed, by a significant margin, Ballot Measure Three, which increases the minimum amount of damages required to guarantee a right to a jury trial for civil proceedings from \$15,000 to \$25,000. While on its face, this may seem bad (it limits your right to a jury trial) it is actually a significant win for our clients.

Prior to this ballot measure, insurance companies could demand a jury trial where the amount requested was greater than \$15,000, which is a significant portion of all motor vehicle collision lawsuits. This would cause the case to be transferred to a different court, where the case would get heard by a jury. It takes a lot longer to get a jury trial, and the procedures related to cases where a jury trial is demanded are much more complex and expensive. Thus, insurance companies employed this tactic to both increase the litigation costs to injury victims and to delay the trial of the case. However, now with the passage of this new law, if a case is filed for \$25,000 or less, the case will not be transferred, and delayed. This new law makes it much more expeditious and less costly for us to get justice for our clients.

The ballot measure will not be a part of the Maryland Constitution until Governor Hogan certifies the results of the election and issues a Proclamation to that effect, which should happen in January of 2023.




